ORDINARY BUSINESS**1 – Receipt of Annual Financial Reports and Appointment of Auditor**

2 – Election of Mr Jason Craig as a Director (Nominated by an Ordinary Level A Member)

To consider, and if thought fit, pass the following resolution as ordinary resolution:

Mr Jason Craig, who is nominated in accordance with Rule 3.3 (a) and offers himself for election as a director of the Company, be elected as a director of the Company.

3 – Election of Robert Imray as a Director (Nominated by a Merchant Association Member)

To consider, and if thought fit, pass the following resolution as an ordinary resolution:

Mr Robert Imray, who is nominated in accordance with Rule 3.3 (a), be elected as a director of the Company.

4 – Election of Michelle Kerr as a Director (Nominated by an Ordinary Level C Member)

To consider, and if thought fit, pass the following resolution as an ordinary resolution:

Ms Michelle Kerr, who is nominated in accordance with Rule 3.3 (a), be elected as a director of the Company.

APPOINTMENT OF PROXY**1. Appointment of Proxy and casting of ballot**

A member who is unable to attend and vote at the meeting may appoint a proxy by completing and returning the attached proxy form in the manner provided below.
