INSTRUCTIONS FOR COMPLETING PROXY FORM

1. Completion of a proxy form will not prevent individual members from attending the Annual General Meeting in person if they wish. Where a member completes and lodges a valid proxy form and attends the Annual General Meeting in person, then the proxy's authority to speak and vote for that member is suspended while the member is present at the Annual General Meeting.
2. A proxy need not be a member of the Company.
3. If you mark the abstain box for a particular item, you are directing your proxy not to vote on that item on a show of hands or on a poll, and that your votes are not to be counted in computing the required majority on a poll.
4. If a member appoints a Power of Attorney to attend the meeting, a properly executed original (or certified copy) of an appropriate Power of Attorney should be produced for admission to the Annual General Meeting. Previously lodged Powers of Attorney will be disregarded by the Company.

5. **Signing Instructions**

You must sign this form as follows in the spaces provided:

- **Individual:** Where the membership is in one name, the member must sign.
- **Joint Members:** Where membership is held in joint names, any member may sign.
- **Power of Attorney:** If you are signing under a Power of Attorney, you must lodge an original or certified photocopy of the appropriate Power of Attorney with your completed Proxy Form.
- **Companies:** Where the company has a Sole Director, who is also the Sole Company Secretary, this form must be signed by that person.
 - If the company (pursuant to section 204A of the *Corporations Act 2001*) does not have a Company Secretary, a Sole Director can also sign alone.
 - Otherwise this form must be signed by a Director jointly with either another Director or a Company Secretary. Please indicate the office held by signing in the appropriate place.

6. **Lodgement of a Proxy**

A proxy form (and the power of attorney (if any) under which it is signed) and completed ballot must be received at the registered office of the Company via email (no later than 5pm on Monday, 25 October 2021).
