RE: Strategic Fleet Implementation Consultative Paper - Cargo Owners

1. About Grain Trade Australia

Grain Trade Australia (GTA) is a national member association and is the focal point for the commercial grain industry within Australia.

GTA has over 280 organisations as members. Their businesses range from regional family businesses to large national and international trading/storage and handling companies who are involved in grain trading activities, grain storage, grain marketing advisory services, processing grain for human consumption and stock feed milling. GTA Members are substantial employers, from the farm gate through to end point consumption, and notably in rural and regional Australia. GTA's core focus is to 'facilitate trade' in the Australian grain industry. It's products and services, including the Australian Grain Industry Code of Practice, provides a self-regulatory framework across the grain industry to facilitate and promote the trade of grain within the Australian grain value chain.

2. The Strategic Fleet.

The implementation by the Department of Infrastructure, Transport, Regional Development and Local Government (Department) of an Australian Strategic Fleet is of interest to GTA, and its members given they are heavy users of both bulk and container shipping services. GTA members currently operate within a relatively open and transparent shipping market that provides adequate service and flexibility to the industry.

Grain is traded within a challenging and competitive global commodity market. GTA and its members experience open markets that can be impacted by market distorting measures such as tariffs and other trade restrictive arrangements. GTA supports an open and transparent shipping market that will support and not restrict trade.

Within this context, on behalf of its members, GTA provides comment on the Strategic Fleet Implementation and the specific questions raised in the Strategic Fleet Implementation Consultative Paper - Cargo Owners.

3. Responses - Cargo Owners and the Strategic Fleet.

- 1. Would your decision on which vessel to use to move your cargo be influenced by its status of being Australian flagged and crewed?
 - a. GTA members are heavy users of dry bulk and container export shipping services and on occasions (during drought) will also tranship cargo interstate via bulk vessels. The grain market is complex and competitive. Decisions on vessel choice is driven by vessel suitability, market requirements, price and service. Vessels may be hired on a voyage or time charter.
 - b. Any Australian flagged and crewed vessels would be competing to attain business based on their capability, service and price.
 - c. The sale and shipment of bulk grain in a dry bulk vessel is usually made either:

- *i*. on a "Free on Board" (FOB) basis where the cargo buyer/importer is responsible for the bulk vessel selection and appointment vessel and shipping the cargo; and
- *ii.* on a "Cost and Freight" (CNF) basis, in which case the seller is responsible for organising the bulk vessel and shipping the cargo.
- d. Similar sales contracts and shipment arrangements are available for container exports. However, freight is arranged at the container level rather than a freight contract for the entire vessel.
- e. In dry bulk shipping utilisation of any particular fleet and its vessels can be problematic for grain exporters due to berth access windows and load and discharge port constraints (including water and air draft). Similarly, contracted sales volumes will also determine the vessel capacity requirements. These factors place an importance on having access to a broad and extensive range of vessel carrying capacity and physical dimensions. An exporter's ability to work within the supply chain and to meet customer expectations is constrained without the flexibility of access to the global fleet. This will **not be possible** with a discrete fleet of vessels.
- 2. If there were capacity in the existing Australian major trading shipping fleet, what would be the primary factors that would encourage or discourage your organisation from using those vessels?
 - a. There are a number of factors to be considered when booking a vessel including:
 - i. Cost and Price
 - ii. Location
 - iii. Availability
 - iv. Timing
 - v. Vessel dimensions (for both load and discharge berths)
 - vi. Vessel emission levels
 - vii. Commercial considerations
 - viii. Reputation and capability
 - ix. Vessel cleanliness & previous cargoes
- 3. Presuming strategic fleet freight costs were competitive, what would motivate your organisation to use an Australian flagged vessel? Are there any benefits to your organisation that would be derived from using an Australian flagged vessel (tangible or intangible)?
 - a. GTA cannot answer this question as each of its members may see varying benefits or restraint.
- 4. What issues or problems would you need to resolve to change your current arrangements to use an Australian flagged vessel?
 - a. The vessel would need to satisfy the factors as discussed in 2.a.
- 5. Of the vessel types recommended by the Taskforce, which types of vessels would your business be most likely to utilise in its ordinary operations?
 - *a*. Australian exports of grain are predominately in dry bulk vessels. Grain is also shipped in 20ft and 40ft containers with annual container exports of up to 4 million tonnes.
- 6. Do you move a sufficient volume and type of cargo annually to sustain a strategic fleet vessel? If not, to what degree would your cargo sustain a vessel?
 - a. GTA is not an exporter. GTA members who export grain, or their customers who coordinate vessels to Australian ports will use the international sea freight market to acquire vessels to meet their requirements. Vessels may be hired on a voyage or time charter.
- 7. The strategic fleet will increase the pipeline of Australian seafarers and boost Australia's maritime capabilities, with the long-term benefit of making supply chains more resilient. Would this indirect benefit encourage you to use a strategic fleet vessel in your day-to-day operations?
 - a. Individual GTA members may see benefit to have Australian maritime capabilities. It is noted the Australian labour force appears to be not attracted to careers within the transport industry as demonstrated by the lack of driver availability in the road transport industry.

- b. Labour cost is an important part of operating a vessel. Australia has the ninth highest average wage in the world according to a report by the Organisation for Economic Cooperation and Development and has a poor record in relation to waterfront workplace disputes. These factors may limit the effectiveness and competitiveness of an Australian fleet.
- 8. What other benefits to the Australian business community will a strategic fleet provide?
 - a. GTA is unsure of any benefits that will be provided by a strategic fleet.
 - b. It is important not to impose regulatory constraints on the market or require preferential treatment by exporters, as this will increase risks to Australia exporters, impact on supply chain efficiency and lead to higher costs to Australian producers and consumers in importing countries, which will impact the global competitiveness of Australian grain.
 - c. Given grain is a staple food source this risks further political anxiety around global food security, including the risk of trade distorting and protective policy measures and actions by importing countries.

4. Responses – Requisition and business continuity

- 1. Do your existing arrangements with vessel operators provide for the temporary reassignment of vessels and cargo in extreme or emergency scenarios?
 - a. GTA is not aware of any arrangements that apply in extreme or emergency scenarios. Such situations would generally be dealt with under the commercial contractual terms between the parties (shipper, vessel owner/charterer).
- 2. Do your existing arrangements with vessel operators entitle you to compensation if the movement of your cargo is delayed?
 - a. Vessels are hired under various contractual arrangements. Each contract will normally include provisions, including demurrage penalties, for delays and dispatch (financial reward usually 50% of demurrage rate) for faster than agreed loading.
- 3. Do you have contingency arrangements in place if the vessel you planned to move your cargo on becomes unavailable at short notice?
 - a. Vessels are hired under various contractual arrangements. Each contract will normally include arrangements for vessel substitution.
- 4. In what supply chain disruption events do you foresee your organisation as most likely to call on the strategic fleet to move cargo?
 - a. GTA cannot speculate or foresee such an event occurring.
- 5. If road or rail connections were temporarily halted, is shipping a viable alternative transport mode for your cargo?
 - a. For normal commercial movements road and rail are utilised to move grain to the domestic market and/or to port terminals for export shipment.
 - b. Do to localised regional droughts transhipments from Western Australia and South Australia to the eastern states have occurred either by dry bulk vessels or via rail and /or road transport. The choice in the mode of transport is determined by a range of commercial factors.
- 6. Are there any specific vessel capabilities you require for your cargo that would be difficult to replace if the vessel was requisitioned?
 - a. No. The grain industry exports in dry bulk vessels and via container exports.
- 7. Would you be willing to forgo a degree of short-term certainty in the service a strategic fleet vessel could provide noting the Government's policy intent is to increase Australia's sovereign capabilities and crisis response tools?

a. The risk in the grain supply chain and the level of complexity may not readily support the use of a strategic fleet. Individual GTA members may be willing to forgo some service and certainty. However, given they are servicing international customers and are competing in Australia with global trading companies this support is unlikely to be extensive and cannot measurably increase exposure to risk.

5. Conclusion

GTA welcomes the opportunity offered by the Department of Infrastructure, Transport, Regional Development and Local Government to provide comment on the implementation of a strategic maritime fleet of Australian vessels. It is noted that prior opportunity to engage and for industry to consult with Government regarding this strategy have been somewhat limited.

GTA's members generally support initiatives and Government policy that enhance non-restrictive trade. This strategy does not appear to be market driven, evidenced based, proven to mitigate (and not increase) commercial risks and provide net value for the grain industry and GTA members.

I look forward to further opportunities to engage with the Government and provide input as the strategy is implemented.
